#### **Public Comments**

Maria Crenshaw, Chasing Justice, expressed disappointment in the Commission for the events of the June 14 meeting. She also expressed dissatisfaction with several commissioners in how they conducted themselves during the last few meetings, she mentioned Commissioner Garrett-Ferguson and Co-Chair Ridgeway. She also expressed frustration with the lack of progress the Commission has made and the time wasted on disagreements unrelated to the Commission's work.

LaTonya Goldsby, BLM Cleveland, Citizens for a Safer Cleveland, read a statement calling for Commissioner Garrett-Ferguson to be removed for her conduct during the June 16 meeting. She also expressed her support for Executive Director Goodrick and would like the Commission to reaffirm that he was indeed appointed to be the permanent ED.

Brenda Bickerstaff, citizen of Cleveland, reiterated that due process is an essential part of the Commission's work. She also expressed her dissatisfaction with the Commission.

Michelle Vielle, citizen of Cleveland, expressed her disapproval of a comment made by Commissioner Garrett-Ferguson concerning the influence of families affected by police violence. She expressed how hurtful those comments were. Supports the request that the Commissioner step down, because of the lack of empathy or awareness for victims of gun violence.

Loh, citizen of Cleveland, questioned the qualifications of the Commissioners and the effectiveness of the Commission.

Rosie Palfy, formerly of MHRAC, expressed dissatisfaction with Commissioner Garrett-Ferguson, as she referenced a triggering experience. She expressed dissatisfaction with the lack of action on addressing concerns about decorum and safety brought up during the last meeting and taking action on their own vote regarding the ED. She noted the contradictory statement of Mayor. She noted the debate during the meeting about a lawyer showed a lack of understanding of the process. She also expressed support of the staff.

Kayla, citizen of Cleveland, expressed concern that the Commission is afraid to get into minutia. She expressed concern that the Co-chairs are assuming too much power.

Darnell T. Brewer, D-Cleveland, Garfield Heights (House District 18), expressed his disapproval in the actions of Commissioner Garrett-Ferguson, he reiterated that public officials have to behave in a certain way and be respectful for their constituents and fellow citizens. He implored the Commission to set an example, as any problems with the commission make it harder to argue for police reform back in Columbus, or to argue that Cleveland is improving and could set an example.
