Director's Report (Interim Executive Director Goodrick)

- IED and the Co-chairs attended the Cleveland City Council Budget Committee
 Hearing, while the Committee has not yet voted, they seemed skeptical of the
 Commission's budget requests.
- There are six outstanding records requests, and the CPC is filing for relief in Federal Court. The City argued in a motion to the court that the delay is because of the volume of the records requested. The City also argued that they do not have to share some of the records because they contain LEADS data. The DOJ

- will most likely introduce a motion that says they are opposed to the City's motion.
- The job opening for the Senior Communications Specialist closed on February 16; there were 20 applicants. Zayed will be the commissioner who will sit on the hiring committee.

Committee Reports

Accountability (Wang):

- The Rubric for the Brady-Giglio List and the first revision of the Manual of Rules were finalized. Now work is being done on the Discipline Charts.
- The Committee received its first two appeal cases, CPC 2023-001 and CPC 2024-001.

There was an extensive back and forth concerning how these cases will be handled. It at times became intense.

Budget and Grants (Garrett-Ferguson):

- The Committee is reviewing the Grant application process, hoping to make it more user-friendly and streamlined.
- We are looking at possibly working through another organization to help us distribute grants.

Policy (van Lier):

- Technology WG is reviewing the proposed ShotSpotter GPO and looking into establishing policies concerning the FUSUS, a surveillance system.
- The Committee is also looking at reviewing PTSD protocol.
- The Policy Committee is looking to establish a technology committee between the City and the Commission. Commissioners Garrett-Ferguson and Wang will serve on it
- A Work Group has been established to look into vehicle pursuits.

Public Comment

- Linda Rico, Cleveland resident, Brady-Giglio WG member, said that the BG WG has been very productive in its work. Unfortunately, she does not have a lot of hope for collaboration with the Police, given how uncooperative they have been with records request to oversight in general, and the BG WG in particular. She suggested that Commissioner Wang should not be removed, and that she is a capable WG leader. She expressed hope that the infighting within the Commission would stop.
- Cameron Denassa, Cleveland resident, seconded the previous comment that Wang should stay on, noting she does good work in committees. He expressed disappointment with the Full meeting so far, including how long the public comment section was delayed. He also mentioned concerns he has with policing in Cleveland including the violation of Black citizens' gun rights and the officer shortage.
- Loh expressed concern that CPC meetings are being poorly run. Loh expressed that she also felt that Wang was doing a good job.
- Councilwoman Stephanie House reiterated her comments from the City Council Budget Committee meeting expressing her dissatisfaction with the Commission's work so far,

- and that the meetings have been poorly run. She suggested that the Commissioners work on team building and maybe even go on a retreat to do so.
- Delante Spencer Thomas, Chief Ethics Officer, wanted to point out that Executive Committees are formal public bodies; this means the Open Meetings Act applies to them, so the meetings must be public and with notice. He suggested tat commissioners work with Martin Bielat (CPC staff attorney) to develop a process to take in cases and how to talk and how to not talk about these cases so you do not prejudice the case. want to talk about them publicly. He wanted to make sure the Commission is getting credit where credit is do. He said that there have been many valid criticisms of the Commission, but that not all were. He said that because the Commission had the responsibility of building a system from scratch, it is understandable that it took a long time to take cases. He also said that there has been a lot of other good work done.
- Chris Martin said that none of the Commissioners are using the rules of order properly and are instead using them as a cudgel against each other.
- Kayla Pincus, former Discipline WG member, said that she worked with Commissioner
 Wang extensively during 2023 and often agreed with her on content and thinks she is an
 asset for the commission. However, she said that Wang behaves in an inappropriate and
 disrespectful way and that she is often out of order. She said that Commissioners need
 to keep each other in line, to harness your abilities. This public comment, while
 important, does not reflect the community's voices.
- Richard Jackson, former CPC Co-chair, expressed happiness with the progress that is being made, including establishing Executive Committees. He expressed concern that the division of the workload is inefficient and it is slowing down the work, and he hopes that the ECs would help with that. He emphasized the important roll the Commission has in getting the City into compliance with the Consent Decree.
- Gabe Flores acknowledged the hard work the Commission is doing. However, he
 expressed concern with the internal dynamics between commissioners, suggesting they
 look into communication science programs to help work on improving that dynamic. He
 said that there does not need to be so much animosity within the Commission.
- Rosie Palfy, former MHRAC member, agrees with what has already been said about Commissioner Wang. She did want to note that Wang has done a 180 on many of the issues that were debated tonight. She also expressed concerns about how the staff is being treated. She also expressed concerns about the Commission taking up five year old cases that were ruled to be unfounded.

Reaves moved to adjourn, with unanimous consent.

Meeting adjourned at 9:03.
