Public Comment

Rosie Palfy expressed concern that the City did not file the updated Critical Incident policy that the Mental Health Response Advisory Committee had agreed to with the Federal Court. She noted that they have had similar issues in the past. She recommended that the CPC and MHRAC establish a liaison.

Loh expressed concerns that when the CDP hires officers from outside districts, their Critical Incident training was not on par with Cleveland's. This has resulted in officers who were terminated by other departments failing to follow proper procedures.

Chair pro tem Reaves moved to take a recess.

The Training Committee is meeting next Wednesday, February 27.

The Rules Committee has been working on the CPC's Operations and Procedures Manual and looking to get bylaws into place. The Commissioners had a lengthy discussion about rules regarding attendance, the formation of committees, the selection of co-chairs.
